### **Absentee Ballots**

- A. Absentee ballots shall be conveyed to the Nominating Committee by mail, fax, in person, or as an email attachment.
- B. Absentee ballots delivered in person or by mail must be in a sealed envelope and have the signature of the voting member across the seal of the envelope.
- C. Faxed ballots must have the signature of the voting member on the cover sheet.
- D. No identifying information of the voter should appear on the ballots.
- E. Submitting an absentee ballot removes that member's name from the list of eligible voters at the General Meeting.
- F. All absentee ballots must be received by the Nominating Committee no less than seven (7) days before the election.
